The Commissioners Court of Red River County will receive sealed bids until **10:00 A.M. Wednesday, April 8, 2026**, for the purchase of the following road materials for the period beginning April 17, 2026, and ending April 16, 2027.

Precinct #3 is located at English, Texas
Precinct #4 is located at Boxelder, Texas

Bids must be delivered to the office of the County Auditor by the date and time indicated above. **Bids must be in a sealed envelope and marked "ROAD MATERIAL BID"**. Action on the bids is then at the discretion of the Commissioners Court. The Court reserves the right to refuse all bids and to accept the bid deemed in the best interest of the County. The Commissioners Court will act on these bids Monday April 13, 2026.
