

NOTICE OF NON-JUDICIAL FORECLOSURE SALE

WHEREAS, That certain Deed of Trust (the "**Deed of Trust**"), dated April 6, 2022 from Johanna Sarah Wolfe, Marnie Gaye Delk and Robert James Delk Jr ("**Borrower**"), as Grantor to Carmen Mejia, Trustee, filed for record in Real Property Records of Red River County, Texas, more particularly described therein, which serves as security for a \$36,000.00 promissory note described therein (the "**Note**") executed by Borrower, payable to the order of Challenger Trust, LLC.


