PLEASE PROVIDE THE FOLLOWING INFORMATION AT THE TIME OF YOUR SCHEDULED APPOINTMENT; YOUR APPLICATION/RECERTIFICATION WILL NOT BE COMPLETE WITHOUT ALL DOCUMENTATION NEEDED! (IF ANYTHING ON THE LIST DOES NOT APPLY TO YOU OR YOUR HOUSEHOLD, PLEASE DISREGARD)

- CURRENT DRIVERS LICENSE OR IDENTIFICATION CARD
- SOCIAL SECURITY CARD
- PROOD OF INCOME <u>LAST FOUR PAY CHECK STUBS</u>, STATEMENTS, FOR ALL EARNED OR UNEARNED INCOME
- COPIES OF BANK STATEMENTS FOR <u>PREVIOUS THREE MONTHS</u> PRIOR TO APPLICATION FOR ALL BANK ACCOUNTS (THIS INCLUDES SAVINGS AND CHECKING)
- PROOF OF COUNTY RESIDENCY SUCHA AS <u>COPY OF UTILITY BILL</u> WITH CURRENT CORRECT ADDRESS.
- IF LIVING WITH A FAMILY MEMBER, FRIEND, OR SOMEONE WHO PROVIDES A HOME AND PAYS ALL EXPENSES AND BILLS, PLEASE PROVIDE A <u>SIGNED AND DATED LETTER OR NOTE</u> STATING THEY ARE PAYING THOSE EXPENSES FOR YOU AND PROVIDING YOU A PLACE TO LIVE.
- A COPY OF MOST RECENT SSI OR SSDI APPLICATION DENIAL LETTER, IF YOU HAVE EVER APPLIED FOR SOCIAL SECURITY SUPPLEMENTAL INCOME OR SOCIAL SECURITY DIABLILITY INCOME.
- COPY OF MOST RECENT YEARS TAX RETURN IF SELF EMPLOYED.

THIS INFORMATION IS REQUIRED TO PROCESS AN APPLICATION FOR RRCIHCP. PLEASE REMEMBER THAT BOTH SPOUSE AND APPLICANT MUST SIGN THE APPLICATION AT THE APPOINTMENT AS WELL AS THE CASE RECORD INFORMATION RELEASE FORM.
